Durham University Engagement Event

I spoke at the Federation of Master Builders Northern Conference following the release of their report 'Licence to Build' which calls for a mandatory licensing scheme for builders, to help ensure constituent quality in the industry, and increase consumer confidence.

The issues I spoke about included the skills shortage in the construction industry, and the housing crisis in the UK. A mandatory accreditation scheme could have real potential in improving standards, and increasing the potential for continuous professional development in the industry.


Roberta celebrates the NHS at 70

Roberta appears on Sunday Politics



On Sunday 24 June 2018, I appeared on the BBC's Sunday Politics North East and Cumbria.

The interview covered a range of topics, including NHS and Public Health funding, as well as Durham University's plans for growth.

I was glad to have the opportunity to raise the concerns that many of us share about the future funding of our NHS.

Universal Credit

The full Universal Credit service has recently been rolled out in Durham, and along with Labour colleagues I continue to challenge the Government to put a benefits system in place that will fully support people's needs.

As we have seen, there are a number of issues across the UK with the transition to Universal Credit, with delays for claimants meaning that families are being pushed into debt and the poor administration meaning that many people are struggling to access Universal Credit at all.

I have already met with advice groups and individual claimants in Durham, and have urged the Jobcentre to make the transition as smooth as possible. I am very concerned about the impact Universal Credit will have on people in Durham, and I will continue to work in the constituency and Westminster to deal with these issues, and minimise the impact Universal Credit has on families in Durham.



Advice Surgery Sessions

I have continued to notice more people than ever attending my advice surgeries over the last few months. With cuts to local services, and changes to benefits set to continue, many of my constituents are finding it very hard to make ends meet.

I will continue to work to help residents who need support, and who are struggling to deal with the effects of the unfair and divisive policies being pursued by the Government.

Leaving the EU

Brexit continues to be the key issue in Westminster, with a series of key votes taking place recently.

I supported all of the Lords amendments, and voted against the Government's decision to reject them, except amendment 51, on which I abstained. Instead, I voted for Labour's amendment 51a, which underlines our determination to retain the benefits of the single market, and build on our manifesto commitments.

Exiting the EU on how any Brexit deal will affect universities access to European research funding. The White Paper that the Government has recently released indicates only that "the UK wishes to explore association in research and innovation programmes". After two years of negotiations, it is disappointing that more has not been done to support universities through Brexit.

I remain very concerned that the Government has not delivered a Brexit package that acts in the best interests of the UK, and I will continue to do my best to prevent Brexit negatively affecting Durham and the North East.

MP questions Minister on Rohingya support

As you will remember, last year I visited Rohingya refugee camps in Bangladesh, and this is still an issue I am very concerned about. During a recent debate in Parliament, I questioned the Minister of State for International Development on what the Government is doing to support Rohingya refugees who remain in Bangladesh as monsoon season approaches.

Monsoon season accounts for almost 80% of rainfall in Bangladesh, and refugees face the threat of heavy rain, landslides, diseases and dirty water. As the repatriation of the Rohingya is still taking some time, it is vital that we do all we can to help protect refugees from the dangers of the coming rains, so I will continue to press the Government to take further action to help deal with this crisis.

Roberta holds follow up meeting on CSW

I hosted a follow up to the 62nd Commission on the Status of Women in Parliament, following my recent visit to the Commission.

This was a Cross-Party debate to reinforce the Beijing Platform for Action to advance women's rights, and to challenge regimes that do not support equal rights for women.

It is vital that that we keep this issue high on the political agenda, and I will keep pressing the Government to push for change internationally.



Roberta marches against Trump



On Friday 13 July, I joined the thousands in London who took part in the march against Donald Trump to show my resistance to his dangerous and divisive polices, and it was heartening to see so many people standing up against his racism, sexism and xenophobia.

The march in London saw over 250,000

people in attendance, and was only one of many demonstrations that took place across the UK. The message was clear that thousands and thousands of us reject the warm welcome the Prime Minister gave to President Trump.

I understand that the Prime Minister may feel that she had to meet the President, but she didn't have to roll out the red carpet and provide the level of

pomp and circumstance that we saw over the weekend of 14—15 July. However, it was encouraging to see so many people across the country taking a stand against the awful policies of Donald Trump.

I also totally refute the comments made by the International Trade Secretary Liam Fox, who said that those of us on the march were 'an embarrassment'. In fact, I believe it is the Government that should be ashamed of themselves, for showing support for a President that has started trade wars with allies, separated children from their families and rolled back action on climate change. Everyone who took part was showing a commitment to social justice, inclusion and the hope for a better world



MP meets with Minister to discuss 'Miners Claw'



Along with representatives from the Durham Miners' Association and Laura Pidcock MP, I recently met with the Minster for Disabled People, Health and Work to discuss the Government's decision to not add Dupuytren's contracture to the list of prescribed diseases for which compensation can be sought.

This disease, dubbed 'Miners Claw' causes fingers to bend in towards the palm of the hand making grip almost impossible, and the Industrial Injuries Advisory Council (IACC) recommended that it should be added to the list in 2014.

Despite this, the Government refused to follow this advice, and we met with the Minister to ask her to look again at the evidence, and reverse this decision which will affect many constituents in Durham.

Although the Minister has indicated that the Chief Medical Officer will review the evidence in this case, I will continue to work with the DMA to press the Government to take action on this important issue.

Roberta chairs first Labour Planning Commission

This month, I chaired the first meeting of the Planning Commission, a group that I set up with Andrew Gywnne with Jeremey's support, to help set out planning policy options for the next Labour Government.

The Commission is made up of a number of planning experts and key stakeholders, and will be holding a series of regional meetings across the UK to discuss planning issues with planners, planning leads, developers and residents.



My thanks go to all Planning Commission members for getting us off to such a good start, and the Commission will be officially launched at conference this year. It is clear that there are many problems that need to be addressed within the planning system, such as land availability, training and the role of SME builders amongst others, and the Commission will ensure that Labour has the policies in place to address these and other issues.

It was good to meet up with a delegation of students from Durham Johnston school on their recent visit Parliament.
